EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0718

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

PROCEDURAL HISTORY: On May 19, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant failed without good cause to accept suitable work when offered and was denied unemployment insurance benefits effective July 7, 2019 (decision # 130846). On June 8, 2020, decision # 130846 became final without claimant having filed a timely request for hearing. On October 9, 2020, the Department served notice of another administrative decision, based in part on decision # 130846, concluding claimant received benefits to which he was not entitled and assessing a \$13,840 overpayment claimant was required to repay to the Department (decision # 140952).

On October 15, 2020, claimant filed a late request for hearing on decision # 130846 and a timely request for hearing on decision # 140952. On October 27, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for November 10, 2020 at 9:30 a.m. to consider claimant's late request for hearing on decision # 130846, and if granted, the merits of decision # 130846. Also on October 27, 2020, OAH mailed notice of a hearing scheduled for November 10, 2020 at 10:45 a.m. to consider claimant's timely request for hearing on decision # 140952.

On November 10, 2020, ALJ Janzen conducted a hearing on claimant's request for hearing on decision # 130846, and on November 12, 2020, issued Order No. 20-UI-156316, dismissing claimant's request for hearing as late, without a showing of good cause. Also on November 10, 2020, ALJ Janzen conducted a separate hearing on claimant's request for hearing on decision # 140952, and on November 12, 2020, issued Order No. 20-UI-156323, affirming decision # 140952. On November 16, 2020, claimant filed timely applications for review of Orders No. 20-UI-156316 and 20-UI-156323 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-156316 and 20-UI-156323. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0718 and 2020-EAB-0719).

With claimant's applications for review, claimant submitted a written argument. However, claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the consolidated hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearings as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearings when reaching these decisions. *See* ORS 657.275(2).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 20-UI-156316 and 20-UI-156323 are affirmed.¹
