

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0720

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On August 13, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was unable to work beginning March 29, 2020 and therefore was denied unemployment insurance benefits from March 29, 2020 through August 8, 2020 and until the reason for the denial had ended (decision # 105121). On September 2, 2020, decision # 105121 became final without claimant having filed a timely request for hearing.

On September 23, 2020, claimant filed a late request for hearing. On October 1, 2020, ALJ Kangas issued Order No. 20-UI-154652, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 15, 2020. On October 7, 2020, claimant filed a timely response to the appellant questionnaire. On October 15, 2020, the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 20-UI-154652 was canceled and a hearing would be scheduled to address the timeliness of appellant's hearing request and, if appropriate, the merits of decision # 105121. On October 15, 2020, OAH mailed notice of a hearing scheduled for October 29, 2020 at 9:30 a.m., at which time claimant failed to appear. On October 29, 2020, ALJ Snyder issued Order No. 20-UI-155879, dismissing claimant's hearing request for failure to appear and leaving decision # 105121 undisturbed.

On November 2, 2020, claimant filed a timely request to reopen the October 29, 2020 hearing. ALJ Kangas reviewed claimant's request, and on November 10, 2020, issued Order No. 20-UI-156240, denying claimant's request to reopen the October 29, 2020 hearing, leaving Order No. 20-UI-155879 undisturbed. On November 17, 2020, claimant filed a timely application for review of Order No. 20-UI-156240 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-156240 is affirmed.¹

¹ This decision denies payment of your Unemployment Insurance (UI) benefits. However, you may be eligible for Pandemic Unemployment Assistance (PUA) benefits for the period you are not eligible for other benefits as long as you are unable to work, unavailable for work, or unemployed due to the COVID-19 public health emergency. PUA is a new unemployment benefits program available through the Oregon Employment Department in response to the COVID-19 pandemic.
