

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0743

Order No. 20-UI-156263 Affirmed - Disqualification
Order No. 20-UI-156264 Affirmed – Overpayment and Penalties

PROCEDURAL HISTORY: On September 21, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant refused an offer of suitable work without good cause and was disqualified from receiving unemployment insurance benefits effective April 5, 2020 (decision # 143642). On September 23, 2020, the Department served notice of an administrative decision, based in part on decision # 143642, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$7,530.00 overpayment of regular benefits, a \$9,000 overpayment of Federal Pandemic Unemployment Compensation (FPUC), a \$1,129.50 monetary penalty, and 47 penalty weeks. Claimant filed a timely request for hearing both decisions. On November 6, 2020, ALJ Snyder conducted a hearing, and on November 10, 2020 issued Order No. 20-UI-156263 affirming Decision # 143642, and Order No. 20-UI-156264 affirming the September 23, 2020 overpayment decision. On November 27, 2020, claimant filed an application for review of Orders No. 20-UI-156263 and 20-UI-156264 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-156263 and 20-UI-156264. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0743 and 2020-EAB-0744).

EAB reviewed the entire hearing record and considered claimant's written argument. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order No. 20-UI-156263¹ and Order No. 20-UI-156264 are affirmed.

¹ This decision denies payment of your Unemployment Insurance (UI) benefits. However, you may be eligible for Pandemic Unemployment Assistance (PUA) benefits for the period you are not eligible for other benefits as long as you are unable to work, unavailable for work, or unemployed due to the COVID-19 public health emergency.
