EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0751

Affirmed Disqualification

PROCEDURAL HISTORY: On July 17, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits for the period June 14, 2020 through September 5, 2020, the break between two academic years, because claimant's wages and hours with other employers were not sufficient to entitle her to benefits during the break (decision # 62657). On August 6, 2020, decision # 62657 became final without claimant having filed a timely request for hearing. On August 12, 2020, claimant filed a late request for hearing. On October 22, 2020, ALJ Kangas issued Order No. 20-UI-155607, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 5, 2020. On October 26, 2020, claimant filed a timely response to the appellant questionnaire, and on October 27, 2020 the Office of Administrative Hearings (OAH) mailed claimant a letter stating that Order No. 20-UI-155607 had been vacated and that a hearing would be scheduled to address claimant's late hearing request and, if granted, the merits of decision # 62657.

On October 27, 2020, OAH served notice of a hearing scheduled for November 12, 2020. On November 12, 2020, ALJ Monroe conducted a hearing at which the employer failed to appear, and on November 23, 2020 issued Order No. 20-UI-156778, allowing claimant's late hearing request but affirming decision # 62657. On November 30, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-156778 is affirmed.
