EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0775

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 9, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain unemployment insurance benefits, and assessing a \$2,270 overpayment, a \$816 monetary penalty, and 20 penalty weeks (decision # 200962). On September 29, 2015, decision # 200962 became final without claimant having filed a timely request for hearing. On August 19, 2020, claimant filed a late request for hearing. On October 13, 2020, ALJ Kangas issued Order No. 20-UI-155189, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by October 27, 2020. On November 2, 2020, Order No. 20-UI-155189 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB).

On November 16, 2020, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings (OAH), and a late application for review of Order No. 20-UI-155189 with EAB. On November 19, 2020, ALJ Kangas issued a letter stating that because claimant's questionnaire response was late, OAH would not consider it, and Order No. 20-UI-155189 would remain in effect. This matter is before EAB based on claimant's late application for review of Order No. 20-UI-155189.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-155189 is dismissed without prejudice.

On November 16, 2020, the appellant submitted an application for review of Order No. 20-UI-155189. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than November 2, 2020. The appellant's application for review was therefore late, and the application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. See ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they had good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145.

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is December 24, 2020, making the deadline January 13, 2021 to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed November 16, 2020 is dismissed without prejudice. Order No. 20-UI-155189 remains undisturbed.
