

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0776**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On July 31, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant's weekly benefit amount was reduced by her retirement pay for each week from June 28, 2020 through July 25, 2020 and until the reason for the reduction had ended (decision # 115135). Claimant filed a timely request for hearing. On September 2, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for September 14, 2020 at 8:15 a.m., at which claimant failed to appear. On September 14, 2020, ALJ Murdock issued Order No. 20-UI-153920, dismissing claimant's request for hearing for failure to appear. On September 18, 2020, claimant filed a timely request to reopen the September 14, 2020 hearing. ALJ Kangas considered claimant's request, and on November 19, 2020, issued Order No. 20-UI-156669, denying claimant's request to reopen. On December 9, 2020, claimant filed an application for review of Order No. 20-UI-156669 with the Employment Appeals Board (EAB).

EAB considered claimant's written argument in reaching this decision.

EAB reviewed the entire record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-156669 is affirmed.
