

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0781

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

PROCEDURAL HISTORY: On February 27, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work during the weeks including April 22, 2018 through May 12, 2018 and for that reason was not eligible to receive benefits for those weeks and until the reason for the denial had ended (decision # 92416). On March 18, 2020, decision # 92416 became final without claimant having filed a timely request for hearing. On July 21, 2020, the Department served notice of another administrative decision, based in part on decision # 92416, assessing a \$687.00 overpayment that claimant was required to repay to the Department (decision # 135242). On July 29, 2020, claimant filed a late request for hearing on decision # 92416 and a timely request for hearing on decision # 135242. On November 23, 2020, ALJ Monroe conducted separate hearings for each administrative decision. On December 1, 2020, ALJ Monroe issued Order No. 20-UI-157061, concluding that claimant did not have good cause to file a late request for hearing on decision # 92416 and leaving that decision undisturbed. Also on December 1, 2020, ALJ Monroe issued Order No. 20-UI-157059, affirming decision # 135242. On December 12, 2020, claimant filed applications for review of Orders No. 20-UI-157061 and 20-UI-157059 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-157061 and 20-UI-157059. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0781 and 2020-EAB-0782).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 20-UI-157061 and 20-UI-157059 are affirmed.
