EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0789

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 8, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the period of March 22, 2020 through April 18, 2020, and was therefore not eligible to receive unemployment insurance benefits for those weeks (decision # 72119). Claimant filed a timely request for hearing. On October 7, 2020, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for October 15, 2020 at 8:15 a.m., at which claimant failed to appear. On October 15, 2020, ALJ Davis issued Order No. 20-UI-155310 dismissing claimant's request for hearing based on claimant's failure to appear at the October 15, 2020 hearing. On October 30, 2020, claimant filed a timely request to reopen the October 15, 2020 hearing. On November 12, 2020, OAH served, by mail, notice of a telephone hearing scheduled for November 24, 2020 to consider claimant's request to reopen, and if granted, the merits of decision # 72119.

On November 24, 2020, ALJ Monroe conducted a hearing, and on November 25, 2020, issued Order No. 20-UI-156966, canceling Order No. 20-UI-155310, allowing claimant's request to reopen, and affirming decision # 72119. On December 15, 2020, Order No. 20-UI-156966 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On December 16, 2020, claimant filed a late application for review of Order No. 20-UI-156966 with EAB.

EAB considered the envelope in which claimant mailed her application for review. A copy of the envelope has been provided with this decision.

FINDINGS OF FACT: (1) Order No. 20-UI-156966, mailed to claimant on November 25, 2020, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 20-UI-156966 at 7. Order No. 20-UI-156966 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 15, 2020 to be timely."

(2) On December 16, 2020, claimant filed, by mail, an application for review of Order No. 20-UI-156966 with EAB. The postmark date on the envelope in which claimant mailed her application for review was December 16, 2020.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-156966 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-156966 was due December 15, 2020. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed her application for review of Order No. 20-UI-156966 was December 16, 2020. Therefore, December 16, 2020 was the filing date of claimant's application for review. Because claimant did not file the application for review until December 16, 2020, the application for review was late.

Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the December 15, 2020 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's application for review is dismissed.

DECISION: The application for review filed December 16, 2020 is dismissed. Order No. 20-UI-156966 remains undisturbed.
