

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0792

Affirmed
Requests to Reopen Denied

PROCEDURAL HISTORY: On October 1, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective July 26, 2020 (decision # 143330). On October 2, 2020, the Department served notice of another administrative decision, based in part on decision # 143330, concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits and assessing a \$648.00 overpayment, a \$97.20 monetary penalty and an eight-week penalty disqualification from future benefits (decision # 195257). Claimant filed timely requests for hearings on decisions # 143330 and 195257.

On October 13, 2020, the Office of Administrative Hearings (OAH) mailed notice of a consolidated hearing on decisions # 143330 and 195257 scheduled for October 27, 2020 at 9:30 a.m., at which claimant failed to appear. On October 27, 2020, ALJ Frank issued Orders No. 20-UI-155757 and 20-UI-155758 dismissing claimant's requests for hearing on decisions # 143330 and 195257 based on claimant's failure to appear for the hearing.

On October 29, 2020, claimant filed timely requests to reopen the October 27, 2020 hearing on decisions # 143330 and 195257. On November 5, 2020, OAH mailed notice of a consolidated hearing on claimant's requests to reopen, and if granted, the merits of decisions # 143330 and 195257, scheduled for November 20, 2020 at 2:30 p.m. On November 20, 2020, ALJ Frank conducted the scheduled consolidated hearing at which claimant, the employer and the Department appeared, and on November 24, 2020, issued Orders No. 20-UI-156871 and 20-UI-156870 denying claimant's requests to reopen the October 27, 2020 hearing on decisions # 143330 and 195257. On December 3, 2020, claimant filed timely applications for review of Orders No. 20-UI-156871 and 20-UI-156870 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-156871 and 20-UI-156870. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0791 and 2020-EAB-0792, respectively).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 20-UI-156871 and 20-UI-156870 are affirmed.
