EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0001

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 8, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$402.00 overpayment that claimant was required to repay to the Department, a \$60.30 monetary penalty, and a 3 week penalty disqualification from future benefits (decision # 194129). On March 28, 2017, decision # 194129 became final without claimant having filed a timely request for hearing. On September 23, 2020, claimant filed a late request for hearing on decision # 194129.

On October 26, 2020, ALJ Kangas issued Order No. 20-UI-155721, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 9, 2020. On November 13, 2020, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 20-UI-155721 with the Employment Appeals Board (EAB). On December 3, 2020, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's November 13, 2020 application for review of Order No. 20-UI-155721.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, a copy of which has been provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 20-UI-155721 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 194129 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In their response to the appellant questionnaire, claimant indicated that their request for hearing was late because they did not receive a copy of decision # 194129, and did not file a timely request for hearing because they were "going through hardship" after their wife passed away and they lost their home and vehicle. EAB Exhibit 1 at 1-2. Claimant did not explain when these events took place, nor did they explain how or when they came to learn of decision # 194129, or when the events that prevented a timely filing ceased to exist prior to filing their request for hearing on September 23, 2020.

Claimant's response to the appellant questionnaire suggests that claimant may have filed their request for hearing late due to factors beyond their reasonable control or an excusable mistake. However, further inquiry is needed to make that determination. The inquiry should include whether claimant received decision # 194129 and if they did not, when they became aware of the decision, when the factors that prevented a timely filing ceased to exist, and whether claimant's September 23, 2020 hearing request was made within a "reasonable time" after the factors that prevented a timely filing ceased to exist.

Order No. 20-UI-155721 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 194129 should be allowed and, if so, the merits of that decision.

DECISION: Order No. 20-UI-155721 is set aside, and this matter remanded for further proceedings consistent with this order.
