

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0014**

*Affirmed ~ Ineligible Weeks 31-20 through 51-20*

**PROCEDURAL HISTORY:** On November 24, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work from July 26, 2020 through November 14, 2020 and was denied benefits for that period and until the reason for the denial had ended (decision # 85750). Claimant filed a timely request for hearing. On December 23, 2020, ALJ Frank conducted a hearing, and on December 30, 2020 issued Order No. 20-UI-158402, modifying decision # 85750 to conclude that claimant was not able to work from July 26, 2020 through December 19, 2020 (weeks 31-20 through 51-21) and was ineligible for benefits for those weeks for that reason. On January 6, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.<sup>1</sup>

**DECISION:** Order No. 20-UI-158402 is affirmed.
