EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0018

Application for Review Dismissed
Benefits Payable for Weeks 25-20 through 30-20, 32-20, and 34-20 through 36-20

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 1, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits from June 14, 2020 through August 22, 2020 during the break between academic years because claimant was likely to return to work after the break (decision #74041). Claimant filed a timely request for hearing. On December 16, 2020, ALJ Scott conducted a hearing, and on December 22, 2020, issued Order No. 20-UI-158015, which concluded "claimant is eligible to receive unemployment insurance benefits during the summer recess period between the 2019-2020 and 2020 and 2021 academic years," but mistakenly affirmed the Department's decision. On January 7, 2021 claimant filed an application for review of Order No. 20-UI-158015 with the Employment Appeals Board (EAB).

On February 8, 2021, ALJ Scott issued Amended Order No. 21-UI-160609, which amended Order No. 20-UI-158015 "to correct a scrivener's error in the Order section." Amended Order No. 21-UI-160609 restated the Findings of Fact, Conclusion of Law, and Opinion of Order No. 20-UI-158015 but modified the Order section to read: "The administrative decision mailed September 1, 2020, is *set aside* affirmed. Claimant is not eligible to receive benefits for the period of June 14, 2020 through July 25, 2020 (Weeks 25-20 through 30-20), August 2 through 8, 2020 (Week 32-20), and August 16, 2020 through September 5, 2020 (Weeks 34-20 through 36-20) under ORS 657.221." [Emphasis and strikethrough in original.]

EAB considered claimant's written argument in reaching this decision.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 20-UI-158015 presents no justiciable controversy and is dismissed.

On January 7, 2021, EAB received from claimant an application for review of Order No. 20-UI-158015 based on what appeared to be a typographical error in that decision. Application for Review at 1. Order No. 20-UI-158015 concluded that, "claimant is eligible to receive unemployment insurance benefits during the summer recess period between the 2019-2020 and 2020 and 2021 academic years," but mistakenly affirmed decision #74041, which denied claimant benefits. However, on February 8, 2021, ALJ Scott issued Amended Order No. 21-UI-160609, "to correct a scrivener's error in the Order section" of Order No. 20-UI-158015. Amended Order No. 21-UI-160609 set aside decision #74041 and clarified that claimant was eligible to receive benefits for the period of June 14, 2020 through July 25, 2020 (weeks 25-20 through 30-20), August 2, 2020 through August 8, 2020 (week 32-20), and August 16, 2020 through September 5, 2020 (weeks 34-20 through 36-20) under ORS 657.221.

Accordingly, there is no justiciable controversy before EAB based upon claimant's January 7, 2021 application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, claimant's application for review of Order No. 20-UI-158015 is dismissed. Amended Order No. 20-UI-160609 remains undisturbed.

DECISION: The application for review of Order No. 20-UI-158015 filed January 7, 2021 is dismissed.
