

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0021

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 26, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which she was not entitled, and assessing an overpayment of \$1,780.00 in unemployment insurance benefits that claimant was required to repay to the Department (decision # 131907). Claimant filed a timely request for hearing. On December 7, 2020, ALJ Snyder conducted a hearing, and on December 11, 2020 issued Order No. 20-UI-157587, affirming decision # 131907. On December 31, 2020, Order No. 20-UI-157587 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On January 8, 2021, claimant filed a late application for review of Order No. 20-UI-157587 with EAB.

FINDING OF FACT: (1) Order No. 20-UI-157587, mailed to claimant on December 11, 2020, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed.” Order No. 20-UI-157587 at 4. Order No. 20-UI-157587 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before December 31, 2020 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 20-UI-157587 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-157587 was due December 31, 2020. Because claimant did not file their application for review until January 8, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the December 31, 2020 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 8, 2021 is dismissed. Order No. 20-UI-157587 remains undisturbed.
