EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0021-R

Request for Reconsideration Granted EAB Decision 2021-EAB-0021 Adhered to on Reconsideration Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 26, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which she was not entitled, and assessing an overpayment of \$1,780.00 in unemployment insurance benefits that claimant was required to repay to the Department (decision # 131907). Claimant filed a timely request for hearing. On December 7, 2020, ALJ Snyder conducted a hearing, and on December 11, 2020 issued Order No. 20-UI-157587, affirming decision # 131907. On December 31, 2020, Order No. 20-UI-157587 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On January 8, 2021, claimant filed a late application for review of Order No. 20-UI-157587 with EAB. On January 22, 2021, EAB issued EAB Decision 2021-EAB-0021, dismissing claimant's application for review as late without a showing of good cause. On January 25, 2021, claimant filed a request for reconsideration with EAB. On February 2, 2021, EAB granted claimant's request.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is granted. EAB Decision 2021-EAB-0021 is adhered to on reconsideration.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

The EAB decision under reconsideration concluded that, "because claimant did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the December 31, 2020 deadline," claimant did not show good cause for the late application for review. EAB Decision 2021-EAB-0021 at 2. Claimant included with her request for reconsideration a statement which explained that she faced a number of setbacks when attempting to file her application for review, such as an inconvenient work schedule and seemingly-conflicting information regarding how to file the application for review. Claimant's Request for Reconsideration at 1. However, claimant's statement does not attempt to "correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice" in EAB Decision 2021-EAB-0021 per OAR 471-041-0145(1). Rather, claimant's written statement in support of her request for reconsideration here appears to be an attempt to meet the requirement, under OAR 471-041-0070(3), that a party describe the circumstances that prevented them from filing a timely application for review in order to show good cause for filing a late application for review.

Had claimant filed this written statement with her late application for review of January 8, 2021, EAB would have been permitted to consider whether the circumstances described in her statement constituted good cause for filing the late application for review. Because she did not, EAB is only permitted to consider the information she provided to determine whether EAB properly considered the question of whether claimant had good cause to file a late application for review. Because claimant has not shown that EAB made an error of the type described in OAR 471-041-0145(1), EAB Decision 2021-EAB-0021 is adhered to on reconsideration and Order No. 20-UI-157587 remains undisturbed.

DECISION: The request for reconsideration filed on January 25, 2021 is granted. EAB Decision 2021-EAB-0021 is adhered to on reconsideration.
