# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0022-R

Late Request for Reconsideration Dismissed

**PROCEDURAL HISTORY:** On October 30, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective June 7, 2020 (decision #83030). Claimant filed a timely request for hearing. On December 1, 2020, ALJ Frank convened a hearing at which the employer requested and was granted a two-week continuance of the hearing. On December 15, 2020, ALJ Frank conducted the hearing, and on December 23, 2020 issued Order No. 20-UI-158066, reversing decision #83030 by concluding that claimant's discharge was not for misconduct, and that claimant was not disqualified from receiving benefits based on his work separation from the employer. On January 8, 2021, the employer filed an application for review with the Employment Appeals Board (EAB). On February 11, 2021, EAB issued EAB Decision 2021-EAB-0022, affirming Order No. 20-UI-158066. On March 22, 2021, the employer filed a late request for reconsideration of EAB Decision 2021-EAB-0022 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**FINDING OF FACT:** EAB mailed EAB Decision 2021-EAB-0022 to the parties on February 11, 2021.

**CONCLUSIONS AND REASONS:** The employer's late request for reconsideration of EAB Decision 2021-EAB-0022 is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB mailed Appeals Board Decision 2021-EAB-0022 on February 11, 2021. Under OAR 471-041-0145(2), the request for reconsideration was due by March 3, 2021. The employer's request for reconsideration was filed on March 22, 2021, more than two weeks after the timely filing deadline. OAR 471-041-0145(2) contains no exception to the requirement that a request for reconsideration must be filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. The employer's request for reconsideration therefore is dismissed as untimely.

**DECISION:** The request for reconsideration filed March 22, 2021 is dismissed. Order No. 20-UI-158066 remains undisturbed.
