

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0079

Affirmed
Overpayment Assessed

PROCEDURAL HISTORY: On November 18, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$1,362 in regular unemployment insurance benefits and \$6,000 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 122447). On December 4, 2020, claimant filed a timely request for hearing. On January 12, 2021, ALJ Davis conducted a hearing, and on January 26, 2021 issued Order No. 21-UI-159782, modifying decision # 122447 and assessing an overpayment of \$154 in regular unemployment insurance benefits and \$1,200 in FPUC benefits that claimant was required to repay to the Department. On February 2, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-159782 is affirmed.
