EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0087-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 22, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective March 22, 2020 (decision #74347). On July 13, 2020, decision #74347 became final without claimant having filed a request for hearing. On December 3, 2020, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's request, and on December 21, 2020 issued Order No. 20-UI-157926, dismissing the request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 4, 2021. On December 28, 2020, claimant filed a timely response to the appellant questionnaire. On December 29, 2020, the Office of Administrative Hearings (OAH) mailed claimant a letter stating that Order No. 20-UI-157926 was cancelled and that a hearing would be scheduled to address whether claimant's late request for hearing should be allowed and, if so, the merits of decision #74347. On December 30, 2020, OAH mailed notice of a hearing scheduled for January 13, 2021. On January 13, 2021, ALJ S. Lee conducted a hearing at which the employer failed to appear, and on January 21, 2021 issued Order No. 21-UI-159534, re-dismissing claimant's request for hearing as late without good cause, leaving decision # 74347 undisturbed.

On February 6, 2021, claimant filed a timely application for review of Order No. 21-UI-159534 with the Employment Appeals Board (EAB). On February 24, 2021, EAB issued EAB Decision 2021-EAB-0087, affirming Order No. 21-UI-159534 dismissing claimant's late request for hearing. On March 20, 2021, claimant filed a request for reconsideration of EAB Decision 2021-EAB-0087 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's late request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment

Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB Decision 2021-EAB-0087 was mailed to the parties on February 24, 2021. The deadline for claimant to file a timely request for reconsideration was March 16, 2021. Claimant's request for reconsideration was filed on March 20, 2021, more than 20 days after EAB Decision 2021-EAB-0087 was mailed, and did not include a statement that a copy of the request for reconsideration was provided to the other parties. For those reasons, under OAR 471-041-0145(2), claimant's request for reconsideration is dismissed.

DECISION: Claimant's request for reconsideration filed March 20, 2021 is dismissed. Order No. 21-UI-159534 remains undisturbed.
