# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0102

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On October 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which claimant was not entitled for the week of April 5, 2020 through April 11, 2020 and assessing an overpayment of \$151 in regular unemployment insurance benefits and \$600 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision #134455). Also on October 5, 2020, the Department served notice of an administrative decision concluding that claimant received benefits to which claimant was not entitled for the week of June 28, 2020 through July 4, 2020 and assessing an overpayment of \$151 in regular unemployment insurance benefits and \$600 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision #133654). Claimant filed a timely request for hearing on each administrative decision. On November 2, 2020, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing scheduled for November 16, 2020 at 10:45 a.m. to address both administrative decisions. On November 16, 2020, claimant failed to appear at the hearing, and ALJ Snyder issued Orders No. 20-UI-156469 and 20-UI-156468, dismissing claimant's request for hearing on decisions # 133654 and # 134455, respectively, for failing to appear. On December 7, 2020, Orders No. 20-UI-156469 and 20-UI-156468 became final without claimant having filed a timely request to reopen the hearing.

On December 17, 2020, claimant filed a late request to reopen the hearing. ALJ Snyder considered claimant's request, and on December 29, 2020 issued Orders No. 20-UI-158335 and 20-UI-158336, denying claimant's request to reopen the hearing on decisions # 133654 and # 134455, respectively, as late without a showing of good cause. On January 11, 2021, claimant filed applications for review of Orders No. 20-UI-158335 and 20-UI-158336 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-158335 and 20-UI-158336. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0103 and 2021-EAB-0102).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 20-UI-158335 and 20-UI-158336 are affirmed.
