

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0107

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 19, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective May 31, 2020 (decision # 124231). Claimant filed a timely request for hearing. On December 9, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for December 22, 2020 at 1:30 p.m., at which time claimant failed to appear. On December 22, 2020, ALJ Scott issued Order No. 20-UI-158027, dismissing claimant's hearing request for failure to appear. On January 6, 2021, claimant filed a timely request to reopen the hearing. ALJ Kangas reviewed claimant's request, and on January 19, 2021 issued Order No. 21-UI-159323, denying the request and leaving Order No. 20-UI-158027 undisturbed. On February 8, 2021, Order No. 21-UI-159323 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On February 10, 2021, claimant filed a late application for review of Order No. 21-UI-159323 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-159323, mailed to claimant on January 19, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 21-UI-159323 at 3. Order No. 21-UI-159323 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 8, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-159323 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late

application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-159323 was due February 8, 2021. Because claimant did not file their application for review until February 10, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the February 8, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed February 10, 2021 is dismissed. Order No. 21-UI-159323 remains undisturbed.
