

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0128**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On October 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$3,206 in regular unemployment insurance benefits and \$7,800 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department by deduction from future benefits (decision # 152542). Claimant filed a timely request for hearing. On November 3, 2020, ALJ S. Lee conducted a hearing, and on November 9, 2020, issued Order No. 20-UI-156204, affirming decision # 152542. On November 30, 2020, Order No. 20-UI-156204 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On February 16, 2021, claimant filed a late application for review of Order No. 20-UI-156204 with EAB.

**FINDING OF FACT:** (1) Order No. 20-UI-156204, mailed to claimant on November 9, 2020, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed.” Order No. 20-UI-156204 at 5. Order No. 20-UI-156204 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before November 30, 2020 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 20-UI-156204 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1)(May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-156204 was due November 30, 2020. Because claimant did not file their application for review until February 16, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the November 30, 2020 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed February 16, 2021 is dismissed. Order No. 20-UI-156204 remains undisturbed.
