

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0141**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On February 4, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective October 20, 2019 (decision # 145039). On February 24, 2020, decision # 145039 became final without claimant having filed a timely request for hearing. On October 17, 2020, claimant filed a late request for hearing. On October 26, 2020, ALJ Kangas issued Order No. 20-UI-155725, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 9, 2020. Claimant failed to file a response to the appellant questionnaire. On November 16, 2020, Order No. 20-UI-155725 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On February 26, 2021, claimant filed a late application for review of Order No. 20-UI-155725 with EAB.

**FINDINGS OF FACT:** (1) Order No. 20-UI-155725, mailed to claimant on October 26, 2020, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 20-UI-155725 at 2. Order No. 20-UI-155725 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 16, 2020."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 20-UI-155725 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-155725 was due November 16, 2020. Because claimant did not file their application for review until February 26, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe any circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed February 26, 2021 is dismissed. Order No. 20-UI-155725 remains undisturbed.
