

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0152**

*Late Applications for Review Dismissed*

**PROCEDURAL HISTORY:** On December 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective April 5, 2020 (decision # 150247). Also on December 9, 2020, the Department served notice of an administrative decision concluding that claimant was unavailable for work from April 26, 2020 through May 16, 2020 and therefore was denied benefits for that period (decision # 151652). Claimant filed timely requests for hearing on decisions # 150247 and # 151652. On January 25, 2021, ALJ Amesbury conducted hearings on decisions # 150247<sup>1</sup> and # 151652. On January 26, 2021, ALJ Amesbury issued Order No. 21-UI-159753, modifying decision # 150247 by concluding that claimant quit work without good cause and was subject to disqualification effective April 19, 2020. Also on January 26, 2020, ALJ Amesbury issued Order No. 21-UI-159789, affirming decision # 151652. On February 16, 2021, Orders No. 21-UI-159753 and 21-UI-159789 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On February 17, 2021, claimant filed late applications for review of Orders No. 21-UI-159753 and 21-UI-159789 with EAB.

EAB considered the envelope in which claimant mailed her applications for review. A copy of the envelope has been provided with these decisions.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-159753 and 21-UI-159789. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0152 and 2021-EAB-0153).

<sup>1</sup> The employer did not appear at the hearing on decision # 150247, although they were a party to the decision. On January 27, 2021, the employer submitted a request to the Office of Administrative Hearings to reopen the hearing. Department records show that OAH has not responded to the employer's request. EAB lacks jurisdiction to address the employer's request to reopen the decision, and therefore does not address it in this decision. Further, because the employer prevailed at the hearing despite their failure to appear, the matter presented in Order No. 21-UI-159753 is non-justiciable by EAB in response to an appeal from the employer.

**FINDINGS OF FACT:** (1) Order No. 21-UI-159753, mailed to claimant on January 26, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed.” Order No. 21-UI-159753 at 4. Order No. 21-UI-159753 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before February 16, 2021 to be timely.”

(2) Order No. 21-UI-159789, mailed to claimant on January 26, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed.” Order No. 21-UI-159789 at 4. Order No. 21-UI-159789 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before February 16, 2021 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late applications for review of Orders No. 21-UI-159753 and 21-UI-159789 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-159753 and 21-UI-159789 were due by February 16, 2021. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed her applications for review was February 17, 2021; that date is therefore the filing date. Because claimant did not file her applications for review until February 17, 2021, one day after the date they were due, the applications for review were late.

Claimant provided a written statement with the applications for review. However, claimant’s written statement did not describe circumstances that prevented her from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant’s late applications for review are dismissed.

**DECISION:** The applications for review filed February 17, 2021 are dismissed. Orders No. 21-UI-159753 and 21-UI-159789 remain undisturbed.
