EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0162

Affirmed Overpayment Assessed

PROCEDURAL HISTORY: On November 19, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$663.00 overpayment that claimant was required to repay to the Department, a \$198.90 monetary penalty, and a five week penalty disqualification from future benefits (decision # 200606). On November 24, 2020, the Department served notice of an administrative decision, based in part on decision # 200606, concluding that claimant also received Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled and assessing an overpayment of \$2,400.00 in FPUC benefits that claimant was required to repay to the Department. Claimant filed a timely request for hearing on both decisions.

On January 25, 2021, the Department issued an amended administrative decision which replaced both decision # 200606 and the November 24, 2020 decision to conclude that claimant was overpaid a total of \$864.00 in regular benefits and \$2,400.00 in FPUC benefits, but that she did not willfully make a misrepresentation in order to obtain benefits and therefore was not assessed a monetary penalty or penalty weeks. On January 26, 2021, ALJ Monroe conducted a consolidated hearing, which was continued on February 18, 2021. On February 26, 2021, ALJ Monroe issued Orders No. 21-UI-161766 and 21-UI-161768, affirming the January 25, 2021 decision. On March 5, 2021, claimant filed an application for review of Orders No. 21-UI-161766 and 21-UI-161768 with the Employment Appeals Board (EAB).

¹ Orders No. 21-UI-161766 and 21-UI-161768 relate to decision # 200606 and the November 24, 2020 decision, respectively, but were issued substantially in duplicate because both administrative decisions were replaced by the January 25, 2021 decision, which globally addressed the substance of both prior administrative decisions. The conclusions of the orders under review indicated that the respective administrative decisions were modified, rather than affirmed. Order No. 21-UI-161766 at 7; Order No. 21-UI-161768 at 7. However, both orders under review reached conclusions that are identical to the January 25, 2021 administrative decision.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-161766 and 21-UI-161768. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0163 and 2021-EAB-0162).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-161766 and 21-UI-161768 are affirmed.
