# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0165-R

Request for Reconsideration Allowed EAB Decision 2021-EAB-0165 Adhered to On Reconsideration Disqualification

**PROCEDURAL HISTORY:** On November 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective June 21, 2020 (decision # 153657). On November 30, 2020, decision # 153657 became final without claimant having filed a request for hearing. On January 13, 2021, claimant filed a late request for hearing. On February 2, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 18, 2021 to consider claimant's late request for hearing and, if allowed, the merits of decision # 153657. On February 4, 2021, OAH served notice that the date of the hearing had changed to February 19, 2021. On February 19, 2021, ALJ Meerdink conducted a hearing at which the employer failed to appear, and issued Order No. 21-UI-161283, dismissing claimant's late request for hearing as late without good cause. On March 8, 2021, claimant filed an application for review with the Employment Appeals Board (EAB). On March 17, 2021, EAB issued EAB Decision 2021-EAB-0165, affirming Order No. 21-UI-161283.

On March 26, 2021, after EAB issued EAB Decision 2021-EAB-0165, EAB received from claimant a timely-filed written argument, which EAB construed as a timely request for reconsideration of EAB Decision 2021-EAB-0165. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0165 is adhered to on reconsideration.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019).

Claimant filed a timely written argument. EAB's decision to issue EAB Decision 2021-EAB-0165 before the written argument due date was error. Claimant's request for reconsideration therefore is allowed.

Order No. 21-UI-161283 dismissed claimant's request for hearing on decision # 153657 as late without a showing of good cause. EAB Decision 2021-EAB-0165, which affirmed Order No. 21-UI-161283, solely addressed that order's ruling on whether claimant had good cause to file a late request for hearing. The bulk of claimant's written argument and attached documents address the merits of decision # 153657, regarding whether claimant was discharged for misconduct connected with work, and does not explain why claimant filed the request for hearing late, or suggest that EAB made an error of law in concluding that claimant did not have good cause for the late filing. Nor does the record otherwise show that EAB made an error of law in concluding that claimant did not have good cause for the late filing, and affirming Order No. 21-UI-161283. For these reasons, EAB Decision 2021-EAB-0165 is adhered to on reconsideration.

**DECISION:** Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0165 is adhered to on reconsideration.
