

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0183

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 27, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective January 5, 2020 (decision # 93100). Claimant filed a timely request for hearing. On February 11, 2021, ALJ Demarest conducted a hearing and issued Order No. 21-UI-160949, concluding the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits. On March 3, 2021, Order No. 21-UI-160949 became final without the employer having filed a timely application for review with the Employment Appeals Board (EAB). On March 11, 2021, the employer filed a late application for review of Order No. 20-UI-160949 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-160949, mailed to the employer on February 11, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed.” Order No. 21-UI-160949 at 3. Order No. 21-UI-160949 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before March 3, 2021 to be timely.”

CONCLUSIONS AND REASONS: The employer’s late application for review of Order No. 21-UI-160949 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-160949 was due on March 3, 2021. Because the employer did not file their application for review until March 11, 2021, the application for review was late. The employer provided a written statement with the application for review. However, the employer's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed March 11, 2021 is dismissed. Order No. 21-UI-160949 remains undisturbed.
