

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0187

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 18, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective October 11, 2020 (decision # 101956). On January 7, 2021, decision # 101956 became final without claimant having filed a request for hearing. On January 14, 2021, claimant filed a late request for hearing. On January 27, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 17, 2021 to consider claimant's late request for hearing and, if allowed, the merits of decision # 101956. On February 17, 2021, ALJ Monroe conducted the hearing, and on February 25, 2021 issued Order No. 21-UI-161655, dismissing claimant's request for hearing as late without good cause and leaving decision # 101956 undisturbed. On March 15, 2021, claimant filed an application for review of Order No. 21-UI-161655 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-161655 is affirmed.
