EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0188-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On November 27, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective March 15, 2020 (decision # 53436). Claimant filed a timely request for hearing. On March 1, 2021, ALJ Murdock conducted a hearing, and on March 2, 2021 issued Order No. 21-UI-161933, affirming decision # 53436. On March 15, 2021, claimant filed an application for review with the Employment Appeals Board (EAB). On April 21, 2021, EAB issued EAB Decision 2021-EAB-0188, affirming Order No. 21-UI-161933. On April 26, 2021, claimant filed a request for reconsideration with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

FINDING OF FACT: (1) Claimant's request for reconsideration did not include a statement that a copy of the request was provided to the other parties.

CONCLUSIONS AND REASONS: Claimant's request for reconsideration of EAB Decision 2021-EAB-0188 is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

The appellant's request for reconsideration includes no statement that a copy was provided to the other parties. OAR 471-041-0145(2)(a). The reconsideration request is, therefore, dismissed. EAB Decision 2021-EAB-0188 remains undisturbed, and EAB will take no further action with regard to this matter.

Even had EAB allowed claimant's request for reconsideration, EAB would have adhered to EAB Decision 2021-EAB-0188. OAR 471-030-0038(5)(a) (September 22, 2020) provides, in relevant part, that an individual "has left work with good cause only if the offer is definite." When claimant gave two weeks' notice on March 7, 2020 that she intended to quit work on March 21, 2020, her employment offer from Legacy Health was not definite. The "Offer Acceptance Follow Up" from Legacy Health on March 5, 2020 states that the job offer was contingent upon claimant's "successful completion" of a criminal background check, a pre-employment drug screen, and a pre-employment health assessment. Exhibit 1 at 17. Even if claimant completed the drug screen on March 7, 2020, the record does not show that claimant had passed the drug screen when she gave notice to the employer that same day. In addition, even though claimant asserted at hearing that the health assessment was not "pass/fail," it was a condition of the job offer that she complete the health assessment. Audio Record at 13:33 to 13:39. Claimant did not complete the health assessment until March 23, 2020, which was after her employment with the employer had ended.

DECISION: The request for reconsideration filed April 26, 2021 is dismissed. Order No. 21-UI-161933 remains undisturbed.
