EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0197-R

Request for Reconsideration Allowed EAB Decision 2021-EAB-0197 Adhered to On Reconsideration Disqualification

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective July 19, 2020 (decision # 120307). On December 30, 2020, decision # 120307 became final without claimant having filed a timely request for hearing. On January 5, 2021, claimant filed a late request for hearing.

ALJ Kangas considered claimant's late request for hearing, and on January 21, 2021 issued Order No. 21-UI-159544, dismissing the request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 4, 2021. On January 27, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee considered claimant's response, and on March 1, 2021 issued Order No. 21-UI-161786, cancelling Order No. 21-UI-159544, re-dismissing claimant's late request for hearing, and leaving decision # 120307 undisturbed. On March 13, 2021, claimant filed an application for review of Order No. 21-UI-161786 with the Employment Appeals Board (EAB). On March 25, 2021, EAB issued EAB Decision 2021-EAB-0197, affirming Order No. 21-UI-161786.

On April 12, 2021, after EAB issued EAB Decision 2021-EAB-0197, EAB received from claimant a timely-filed written argument, which EAB construed as a timely request for reconsideration of EAB Decision 2021-EAB-0197. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0197 is adhered to on reconsideration.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule,

or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019).

Claimant filed a timely written argument. EAB's decision to issue EAB Decision 2021-EAB-0197 before the written argument due date was error. Claimant's request for reconsideration therefore is allowed.

Order No. 21-UI-161786 dismissed claimant's request for hearing on decision # 120307 as late without a showing of good cause. EAB Decision 2021-EAB-0197, which affirmed Order No. 21-UI-161786, solely addressed that order's ruling on whether claimant had good cause to file a late request for hearing. Claimant's written argument addresses only the merits of decision # 120307, regarding whether claimant had good cause to quit work, and does not explain why claimant filed the request for hearing late, or suggest that EAB made an error of law in concluding that claimant did not have good cause for the late filing. Nor does the record otherwise show that EAB made an error of law in concluding that claimant did not have good cause for the late filing, and affirming Order No. 21-UI-161786. For these reasons, EAB Decision 2021-EAB-0197 is adhered to on reconsideration.

DECISION: Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0197 is adhered to on reconsideration.
