

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0198

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 15, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective June 21, 2020 (decision # 101812). On January 4, 2021, decision # 101812 became final without claimant having filed a request for hearing. On January 10, 2021, claimant filed a late request for hearing.

On January 21, 2021, ALJ Kangas issued Order No. 21-UI-159484, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 4, 2021. On February 10, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-159484 with the Employment Appeals Board (EAB). On March 17, 2021, ALJ Kangas mailed a letter to claimant stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's February 10, 2021 application for review of Order No. 21-UI-159484.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 21-UI-159484 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 101812 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Claimant's request for hearing on decision # 101812 was due by January 4, 2021. Because they did not file their request for hearing until January 10, 2021, the request was late. Claimant stated in their appellant questionnaire response that they did not file the hearing request before the timely filing deadline because they had hand surgery and had been hospitalized. EAB Exhibit 1 at 2. They also stated on the questionnaire that there was nothing they could have done to meet the timely filing deadline. EAB Exhibit 1 at 2. If claimant was hospitalized or otherwise incapacitated at the time the request for hearing was due, claimant may have missed the timely filing deadline due to circumstances beyond their control. However, further inquiry is needed to determine when claimant was hospitalized or otherwise incapacitated, when they actually received or was otherwise made aware of decision # 101812, what other factors, if any, prevented claimant from filing a timely request for hearing on decision # 101812, and whether claimant filed their request for hearing within a reasonable time (seven days) after any such factors ceased to exist. The ALJ should also ask any other questions that develop in the course of conducting the hearing.

Order No. 21-UI-159484 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 101812.

DECISION: Order No. 21-UI-159484 is set aside, and this matter remanded for further proceedings consistent with this order.
