EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0210

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective December 29, 2019 (decision # 112418). On December 30, 2020, decision # 112418 became final without claimant having filed a timely request for hearing. On January 21, 2021, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's hearing request, and on February 9, 2021, issued Order No. 21-UI-160588, dismissing claimant request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 23, 2021.

On February 25, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-160588 with the Employment Appeals Board (EAB). On March 17, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 21-UI-160588 remained in effect. This matter is before EAB based upon claimant's timely application for review of Order No. 21-UI-160588.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) On December 10, 2020, the Department mailed decision # 112418 to claimant's address on file with the Department. Decision # 112418 stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than

December 30, 2020." Exhibit 1 at 2. Decision #112418 provided a mailing address, telephone numbers, and a fax number for use to contact the Department. Exhibit 1 at 1.

(2) On December 20, 2020, claimant received decision # 112418. EAB Exhibit 1 at 1. Claimant delayed filing their request for hearing until January 21, 2021 because "[they] had taken responsibility to care for younger siblings with school and had hoped [they'd] find employment." EAB Exhibit 1 at 2. Claimant's request for hearing included this reason for why claimant delayed filing their request for hearing until January 21, 2021. Exhibit 2.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 112418 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

On December 10, 2020, the Department mailed decision # 112418 to claimant at claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on that decision was December 30, 2020. Claimant did not file a request for hearing on decision # 112418 until January 21, 2021. Accordingly, claimant's request for hearing was late.

Claimant did not establish that factors beyond their reasonable control prevented them from filing a timely hearing request on decision # 112418. In their appellant questionnaire, claimant acknowledged receipt of decision # 112418 on December 20, 2020. EAB Exhibit 1 at 1. Claimant stated in their appellant questionnaire that they delayed filing their request for hearing until January 21, 2021 because they were caring for younger siblings. EAB Exhibit 1 at 2. This assertion is not sufficient to establish that factors beyond claimant's reasonable control prevented them from filing a timely request for hearing. Decision # 112418 provided a mailing address, telephone numbers, and a fax number for use in contacting the Department. Thus, although claimant may have experienced problems with contacting the Department during certain hours of the day, contacting the Department by mail, telephone, or fax to file a request for hearing by or before December 30, 2020 remained within claimant's reasonable control.

To any extent claimant's failure to file a timely hearing request was the result of a mistake on claimant's part, it was not an "excusable mistake" within the meaning of the administrative rules. The record does not, for example, raise a due process issue, and fails to show that any mistake was the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Because claimant failed to show that factors beyond their reasonable control or an excusable mistake prevented them from filing a hearing request by the December 30, 2020 deadline, claimant failed to establish good cause to extend the filing deadline for a hearing request beyond that date. Accordingly, claimant's late request for hearing is dismissed.

DECISION: Order No. 21-UI-160588 is affirmed.
