# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0212

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On January 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective August 9, 2020 (decision # 121504). Claimant filed a timely request for hearing. On February 23, 2020, ALJ Frank conducted a hearing, and on March 1, 2021 issued Order No. 21-UI-161823, modifying decision # 121504 to conclude that claimant was discharged for misconduct and disqualified from receiving benefits effective July 26, 2020. On March 22, 2021, Order No. 21-UI-161823 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On March 23, 2021, claimant filed a late application for review of Order No. 21-UI-161823 with EAB.

EAB considered the record and the envelope in which claimant mailed their application for review when reaching this decision. A copy of the envelope has been provided with this decision.

**FINDING OF FACT:** (1) Order No. 21-UI-161823, mailed to claimant on March 1, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 21-UI-161823 at 4. Order No. 21-UI-161823 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 22, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-161823 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-161823 was due by March 22, 2021. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was March 23, 2021; that date is therefore the filing date. Because claimant did not file their application for review until March 23, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the March 22, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed March 23, 2021 is dismissed. Order No. 21-UI-161823 remains undisturbed.
