

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0228**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On December 9, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits. On December 29, 2020, the December 9, 2020 Notice of Determination for PUA decision became final without claimant having filed a request for hearing. On January 4, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request for hearing, and on January 13, 2021 issued Order No. 21-UI-159054, dismissing the request as untimely without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 27, 2021. On January 19, 2021, claimant filed a timely response to the appellant questionnaire. On February 18, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 2, 2021 to consider claimant's late request for hearing and, if allowed, the merits of the December 9, 2020 Notice of Determination for PUA decision. On March 2, 2021, ALJ Monroe conducted the hearing and, on March 5, 2021, issued Order No. 21-UI-162211 dismissing claimant's late request for hearing as late without good cause. On March 30, 2021, claimant filed a late application for review of Order No. 21-UI-162211 with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-162211, mailed to claimant on March 5, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-162211 at 4. Order No. 21-UI-162211 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 25, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-162211 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-162211 was due on March 25, 2021. Because claimant did not file their application for review until March 30, 2021, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the March 25, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed March 30, 2021 is dismissed. Order No. 21-UI-162211 remains undisturbed.
