

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0237**

*Affirmed*  
*Ineligible Weeks 19-20 through 23-20*

**PROCEDURAL HISTORY:** On January 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work during each of the weeks including May 3, 2020 through August 8, 2020 (weeks 19-20 through 32-20) and was denied benefits for those weeks (decision # 61435). Claimant filed a timely request for hearing. On March 4, 2021, ALJ S. Lee conducted a hearing, and on March 10, 2021 issued Order No. 21-UI-162464, modifying decision # 61435 to conclude that claimant was not able to work and therefore ineligible for benefits for the weeks including May 3, 2020 through June 6, 2020 (weeks 19-20 through 23-20). On March 29, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant did not declare that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond her reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-162464 is affirmed.
