# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0239

Affirmed
Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On December 15, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective April 12, 2020 (decision # 91923). On January 4, 2021, decision # 91923 became final without claimant having filed a request for hearing. On January 21, 2021, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's hearing request, and on February 8, 2021 issued Order No. 21-UI-160617, dismissing claimant request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 22, 2021.

On February 25, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-160617 with the Employment Appeals Board (EAB). On March 17, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 21-UI-160617 remained in effect. This matter is before EAB based upon claimant's February 25, 2021 application for review of Order No. 21-UI-160617.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) On December 15, 2020, the Department mailed decision #91923 to claimant's address on file with the Department. Decision #91923 stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than

January 4, 2021." Exhibit 1 at 2. Decision # 91923 also stated, "If you do not understand this decision, contact the Unemployment Insurance Center above immediately." Exhibit 1 at 2.

(2) On December 15, 2020, claimant received decision #91923. EAB Exhibit 1 at 1. Claimant delayed filing their request for hearing because on an unspecified date, "[claimant] spoke with an administrator with OED [and] thought [their] right to appeal was underway." EAB Exhibit 1 at 2. Claimant filed their request for hearing on January 21, 2021 after realizing on an unspecified date that "the appeal was not underway." EAB Exhibit 1 at 2.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing on decision # 91923 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. OAR 471-040-0010(1)(b)(B) provides that good cause does not include not understanding the implications of a decision or notice when it is received.

On December 15, 2020, the Department mailed decision #91923 to claimant at claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on that decision was January 4, 2021. Claimant did not file a request for hearing on decision #91923 until January 21, 2021. Accordingly, claimant's request for hearing was late.

The record does not show good cause to extend the 20-day deadline to request a hearing. Claimant did not establish that factors beyond their reasonable control prevented them from filing a timely hearing request on decision #91923. In their appellant questionnaire, claimant acknowledged receipt of decision #91923 on December 15, 2020. EAB Exhibit 1 at 1. Claimant explained that they delayed filing their request for hearing until January 21, 2021 because on an unspecified date, claimant spoke with a Department employee and misunderstood, based on their conversation, that they had appealed the decision. EAB Exhibit 1 at 2. In their questionnaire response, claimant did not explain why they assumed, based on the conversation, that they had appealed decision #91923 or show why such an assumption was reasonable. Claimant's assertions are not sufficient to establish that factors beyond claimant's reasonable control prevented them from filing a timely request for hearing. And to any extent claimant's failure to file a timely hearing request was the result of a mistake on claimant's part, it was not an "excusable mistake" within the meaning of the administrative rules. The record does not, for example, raise a due process issue, and fails to show that any mistake was the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Even if claimant's assertions were sufficient to establish that factors beyond their reasonable control or an excusable mistake prevented them from filing a timely hearing request, they were insufficient to establish that claimant filed their request for hearing within seven days, or a "reasonable time," after those factors ceased to exist. Claimant failed to specify in their response to the appellant questionnaire

when they first "realized the appeal was not underway." Thus, claimant's response does not show that they filed their hearing request within seven days after realizing they had not requested a hearing.

Because claimant failed to show that factors beyond their reasonable control or an excusable mistake prevented them from filing a hearing request by the January 4, 2021 deadline, or that they filed their late request for hearing within a reasonable time, claimant's late request for hearing is dismissed.

**DECISION:** Order No. 21-UI-160617 is affirmed.
