

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0242

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 26, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 3, 2020. On November 16, 2020, the October 26, 2020 Notice of Determination for PUA decision became final without claimant having filed a timely request for hearing. On January 26, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 17, 2021 issued Order No. 21-UI-161081, dismissing the request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 3, 2021. On March 9, 2021, Order No. 21-UI-161081 became final without claimant having responded to the appellant questionnaire or filed a timely application for review with the Employment Appeals Board (EAB). On March 11, 2021, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-161081 with EAB. On March 17, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's March 11, 2021 late application for review of Order No. 21-UI-161081.

FINDING OF FACT: (1) Order No. 21-UI-161081, mailed to claimant on February 17, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 21-UI-161081 at 2. Order No. 21-UI-161081 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than March 9, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-161081 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1)(May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-161081 was due by March 9, 2021. Because claimant did not file their application for review until March 11, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, which therefore is dismissed.

DECISION: The application for review filed March 11, 2021 is dismissed. Order No. 21-UI-161081 remains undisturbed.
