# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0248

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On December 29, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits. On January 19, 2021, the December 29, 2020 Notice of Determination for PUA decision became final without claimant having filed a request for hearing. On February 3, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 25, 2021 issued Order No. 21-UI-161595, dismissing the request as untimely without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 11, 2021. On March 17, 2021, Order No. 21-UI-161595 became final without claimant having responded the appellant questionnaire or filed an application for review of Order No. 21-UI-161595 with the Employment Appeals Board (EAB). On March 24, 2021, claimant filed a late response to the appellant questionnaire. On March 29, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 21-UI-161595 with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-161595, mailed to claimant on February 5, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-161595 at 2. Order No. 21-UI-161595 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than March 17, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-161595 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-161595 was due on March 17, 2021. Because claimant did not file their application for review until April 2, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the March 17, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed April 2, 2021 is dismissed. Order No. 21-UI-161595 remains undisturbed.
