

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0252

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On December 18, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective February 2, 2020 (decision # 91902). Claimant filed a timely request for hearing. On January 13, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 26, 2021 at 2:30 p.m. On January 26, 2021, ALJ Monroe conducted a hearing at which the employer failed to appear, and on January 28, 2021, issued Order No. 21-UI-159955, reversing decision # 91902 to conclude that the employer discharged claimant, but not for misconduct, and that claimant was not disqualified from receiving unemployment insurance benefits based on the work separation. On February 12, 2021, the employer filed a timely request to reopen the January 26, 2021 hearing. ALJ Kangas considered the employer's request, and on March 24, 2021 issued Order No. 21-UI-163305, denying the employer's request to reopen the hearing and leaving Order No. 21-UI-159955 undisturbed. On April 5, 2021, the employer filed a timely application for review of Order No. 21-UI-163305 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information into the hearing record as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-163305 is affirmed.
