EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0253

Affirmed
Late Requests for Hearing Allowed
Ineligible Weeks 14-20 Through 21-20
Overpayment Assessed

PROCEDURAL HISTORY: On October 28, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the weeks including March 29, 2020 through May 23, 2020 (weeks 14-20 through 21-20) and was therefore ineligible to receive unemployment insurance benefits for those weeks (decision # 92327). On November 17, 2020, decision # 92327 became final without claimant having filed a request for hearing. On January 7, 2021, the Department served notice of an administrative decision, based in part on decision # 92327, concluding that claimant received benefits to which she was not entitled and assessing an overpayment of \$2,100 in regular benefits and \$4,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department by deduction from future benefits (decision # 153700). On January 27, 2021, decision # 153700 became final without claimant having filed a request for hearing.

On January 28, 2021, claimant filed late requests for hearing on decisions #92327 and 153700. On February 19, 2021, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing on March 5, 2021 to consider claimant's late requests for hearings on decisions #92327 and 153700 and, if allowed, the merits of those decisions. On March 5, 2021, ALJ Monroe conducted a hearing. On March 15, 2021 ALJ Monroe issued Order No. 21-UI-162727, allowing claimant's late request for hearing on decision #92327 and affirming decision #92327, and Order No. 21-UI-162729, allowing claimant's late request for hearing on decision #153700 and affirming decision #153700. On April 5, 2021, claimant filed applications for review of Orders No. 21-UI-162727 and 21-UI-162729 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-162727 and 21- UI-162729. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0254 and 2021-EAB-0253).

EAB reviewed the entire hearing record for Orders No. 21-UI-162727 and 21- UI-162729. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-162727 and 21- UI-162729 are affirmed.
