EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0278

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On March 20, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective January 19, 2020 (decision # 72724). On April 9, 2020, decision # 72724 became final without claimant having filed a request for hearing. On August 26, 2020, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 1, 2020 issued Order No. 20-UI-153535 dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 15, 2020. On September 11, 2020, claimant filed a timely response to the appellant questionnaire. On September 16, 2020, the Office of Administrative Hearings (OAH) mailed a letter to the parties confirming that Order No. 20-UI-153535 was vacated and a hearing would be scheduled to address the timeliness of claimant's hearing request and, if appropriate, the merits of decision # 72724.

On September 16, 2020, OAH mailed notice of the hearing scheduled for September 29, 2020 at 1:30 p.m. On September 29, 2020, claimant failed to appear at the hearing, and on September 30, 2020, ALJ Toth issued Order No. 20-UI-154623, dismissing claimant's request for hearing for failure to appear. On October 20, 2020, Order No. 20-UI-154623 became final without claimant having filed a request to reopen the September 29, 2020 hearing, or an application for review of Order No. 20-UI-154623 with the Employment Appeals Board (EAB). On February 9, 2021, claimant filed a late request to reopen the September 29, 2020 hearing. ALJ Kangas considered claimant's request, and on March 24, 2021 issued Order No. 21-UI-163299, denying the request as late without a showing of good cause. On April 9, 2021, claimant filed an application for review of Order No. 21-UI-163299 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

FINDINGS OF FACT: (1) On September 30, 2020, OAH mailed Order No. 20-UI-154623 to claimant's address of record with the Department. Order No. 20-UI-154623 stated, "If you did not appear at the hearing, you may request to reopen the hearing. . . . Your request to reopen the hearing must . . . either be filed within 20 days of when the order from the hearing you missed was mailed, or else show that factors or circumstances beyond your reasonable control prevented you from filing your reopen request within that time, in which case you must also show that you filed your hearing request within seven days of when those factors or circumstances ceased to exist." Order No. 20-UI-154623 at 2.

(2) After claimant failed to appear for the September 29, 2020 hearing, claimant thought they were not permitted to "reapply for the appeal" until after claimant spoke to someone from the Department who told them they "could reapply for the appeal." Exhibit 5.

CONCLUSIONS AND REASONS: Claimant's late request to reopen is denied.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. The period within which a party may request reopening may be extended if the party requesting reopening has good cause for failing to request reopening within the time allowed, and acts within a reasonable time. OAR 471-040-0041(1) (February 10, 2012). "Good cause" exists when an action, delay, or failure to act arises from an excusable mistake or from factors beyond an applicant's reasonable control. OAR 471-040-0041(2). "A reasonable time," is seven days after the circumstances that prevented a timely filing ceased to exist. OAR 471-040-0041(3). The party requesting reopening shall set forth the reason(s) for filing a late request to reopen in a written statement, which OAH shall consider in determining whether good cause exists for the late filing, and whether the party acted within a reasonable time. OAR 471-040-0041(4).

Claimant did not show good cause to file a late request to reopen the September 29, 2020 hearing. Claimant explained that they did not understand that they had the right to file a request to reopen until speaking to someone at the Department about having missed the September 29, 2020 hearing. Exhibit 5. Claimant did not establish that it was beyond their reasonable control to read the information contained in Order No. 20-UI-154623 about their right to request to reopen the hearing and to follow the instructions contained in that order to submit a timely request. Although claimant's failure to file the request to reopen on time was likely the result of a mistake on their part, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply. Absent a showing of good cause, claimant's late request to reopen must be denied.

DECISION: Order No. 21-UI-163299 is affirmed.
