

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0279**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On January 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective November 22, 2020 (decision # 112420). Claimant filed a timely request for hearing. On April 6, 2021, ALJ Griffin conducted a hearing at which the employer failed to appear, and on April 8, 2021 issued Order No. 21-UI-164392, affirming decision # 112420. On April 10, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-164392 is affirmed.
