EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0281

Application for Review Dismissed Without Prejudice

Employment Department (the Department) served notice of an administrative decision concluding that the employer suspended claimant, not for misconduct, and that claimant was not disqualified from receiving unemployment insurance benefits (decision #144549). The employer filed a timely request for hearing. On February 23, 2021 the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 10, 2021 at 1:30 p.m. On March 2, 2021, OAH served notice rescheduling the hearing for March 17, 2021 at 1:30 p.m. On March 17, 2021, ALJ Schmidt conducted the hearing, and on March 24, 2021 issued Order No. 21-UI-163339, reversing decision #144549 by concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective November 8, 2020. On April 13, 2021, Order No. 21-UI-163339 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 14, 2021, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On April 14, 2021, the appellant filed an application for review of Order No. 21-UI-163339 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 13, 2021. The appellant's application for review therefore is late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is April 22, 2021, making the deadline May 12, 2021, to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed April 14, 2021 is dismissed without prejudice. Order No. 21-UI-163339 remains undisturbed.
