EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0287

Affirmed
Late Requests for Hearing Denied

PROCEDURAL HISTORY: On October 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective February 16, 2020 (decision # 102625). Also on October 5, 2020, the Department served notice of an administrative decision concluding that claimant was not available for work from March 22, 2020 through September 26, 2020, and was therefore not eligible to receive unemployment insurance benefits for that period, and until the reason for the denial had ended (decision # 111356). On October 26, 2020, decisions # 102625 and # 111356 became final without claimant having filed a request for hearing. On January 19, 2021, the Department served notice of an administrative decision based in part on decision # 11356, concluding that claimant received benefits to which she was not entitled and assessing an overpayment of \$8,883 in regular benefits and \$10,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 162817). On February 8, 2021, decision # 162817 became final without claimant having filed a request for hearing. On February 11, 2021, claimant filed late requests for hearing on decisions # 102625, # 111356, and # 162817.

On March 3, 2021, ALJ Kangas issued Orders No. 21-UI-162028 and 21-UI-162030, dismissing claimant's requests for hearing on decisions # 111356 and # 162817 as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by March 17, 2021. On March 10, 2021, claimant submitted a timely response to the appellant questionnaire. On March 15, 2021, the Office of Administrative Hearings (OAH) issued letters vacating Orders No. 21-UI-162028 and 21-UI-162030, and notifying claimant that hearings would be scheduled to address the timeliness of claimant's hearing requests on decisions # 111356 and 162817, and if appropriate, the merits of those decisions. On March 16, 2021, OAH mailed notice of a consolidated hearing on decisions # 111356 and 162817 scheduled for April 1, 2021 at 9:30 a.m. Also on March 16, 2021, OAH mailed notice of a separate hearing on decision # 102625 scheduled for April 1, 2021 at 10:45 a.m.

On April 1, 2021, ALJ Monroe held a consolidated hearing on decisions # 111356 and # 162817 and a separate hearing on decision # 102625. On April 9, 2021, ALJ Monroe issued Orders No. 21-UI-

164537,¹ 21-UI-164548, and 21-UI-164545, dismissing claimant's late requests for hearing on decisions # 102625, # 111356, and # 162817 as late without a showing of good cause. On April 13, 2021, claimant filed applications for review of Orders No. 21-UI-164537, 21-UI-164548, and 21-UI-164545 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-164537, 21-UI-164548, and 21-UI-164545. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2021-EAB-0286, 2021-EAB-0287, and 2021-EAB-0288).

EAB reviewed the entire combined hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-164537, 21-UI-164548, and 21-UI-164545 are affirmed.
