

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0291

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$5,586 in regular unemployment insurance benefits and \$8,400 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to have deducted from future benefits (decision # 153836). Claimant filed a timely request for hearing. On March 15, 2021, ALJ Monroe conducted a hearing that was interpreted in Vietnamese, and on March 23, 2021 issued Order No. 21-UI-163297, affirming decision # 153836. On April 12, 2021, Order No. 21-UI-163297 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On April 13, 2021, claimant filed a late application for review of Order No. 21-UI-163297 with EAB.

EAB considered the record and the envelope in which claimant mailed their application for review when reaching this decision. A copy of the envelope has been provided with this decision.

FINDING OF FACT: (1) Order No. 21-UI-163297, mailed to claimant on March 23, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-163297 at 6. Order No. 21-UI-163297 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before April 12, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-163297 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing

period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-163297 was due by April 12, 2021. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was April 13, 2021; that date is therefore the filing date. Because claimant did not file their application for review until April 13, 2021, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the April 12, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed April 13, 2021 is dismissed. Order No. 21-UI-163297 remains undisturbed.
