EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0292

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective May 3, 2020 (decision # 134630). On December 30, 2020, decision # 134630 became final without claimant having filed a request for hearing. On December 31, 2020, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on January 7, 2021 issued Order No. 21-UI-158738, dismissing the request as untimely without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 21, 2021. On January 27, 2021, Order No. 21-UI-158738 became final without claimant having responded the appellant questionnaire or filed an application for review of Order No. 21-UI-158738 with the Employment Appeals Board (EAB). On April 13, 2021, claimant filed a late application for review of Order No. 21-UI-158738 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-158738, mailed to claimant on January 7, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-158738 at 2. Order No. 21-UI-158738 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 27, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-158738 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-158738 was due on January 27, 2021. Because claimant did not file their application for review until April 13, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the January 27, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 13, 2021 is dismissed. Order No. 21-UI-158738 remains undisturbed.
