# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0320

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On August 21, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for Best Western Ponderosa Lodge Inc. without good cause and was disqualified from receiving unemployment insurance benefits effective November 24, 2019 (decision #113834). Also on August 21, 2020, the Department served notice of an administrative decision concluding that claimant quit working for Central Oregon Bark without good cause and was disqualified from receiving benefits effective December 29, 2019 (decision #120012). On September 10, 2020, decisions #113834 and #120012 became final without claimant having filed a request for hearing on either decision. On December 7, 2020, claimant filed a late request for hearing on both decisions. ALJ Kangas considered claimant's requests, and on December 28, 2020 issued Orders No. 20-UI-158233 and 20-UI-158232, dismissing the requests as untimely without a showing of good cause, subject to claimant's right to renew the requests by responding to appellant questionnaires by January 11, 2021. On January 11, 2021, claimant filed timely responses to the appellant questionnaires. ALJ Kangas reviewed claimant's questionnaire responses, and on February 1, 2021 issued Orders No. 21-UI-160134 and 21-UI-160139, cancelling and replacing Orders No. 20-UI-158233 and 20-UI-158232, re-dismissing claimant's late requests for hearing on decisions # 113834 and # 120012, and leaving those decisions undisturbed. On February 22, 2021, Orders No. 21-UI-160134 and 21-UI-160139 became final without claimant having filed an application for review with the Employment Appeals Board (EAB) on either order. On April 19, 2021, claimant filed late applications for review of Orders No. 21-UI-160134 and 21-UI-160139 with the EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-160134 and 21-UI-160139. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0319 and 2021-EAB-0320).

**FINDING OF FACTS:** (1) Order No. 21-UI-160134, mailed to claimant on February 1, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-160134 at 3. Order No. 21-UI-160134 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 22, 2021 to be timely."

(2) Order No. 21-UI-160139, mailed to claimant on February 1, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-160139 at 3. Order No. 21-UI-160139 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 22, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late applications for review of Orders No. 21-UI-160134 and 21-UI-160139 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-160134 and 21-UI-160139 were due by February 22, 2021. Because claimant did not file their applications for review until April 19, 2021, the applications for review were late. Claimant's applications for review did not include written statements describing the circumstances that prevented claimant from filing the applications for review by the February 22, 2021 deadline. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

**DECISION:** The applications for review filed April 19, 2021 are dismissed. Orders No. 21-UI-160134 and 21-UI-160139 remain undisturbed.
