

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0327

Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 31, 2020, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report (WPBR) concluding that claimant did not qualify to receive unemployment insurance benefits. On January 11, 2021, the December 31, 2020 WPBR became final without claimant having filed a timely request for hearing. On February 11, 2021, claimant filed a late request for hearing on the December 31, 2020 WPBR. ALJ Kangas reviewed claimant's hearing request, and on March 4, 2021 issued Order No. 21-UI-162134, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 18, 2021. On March 24, 2021, Order No. 21-UI-162134 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 31, 2021, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-162134 with the Employment Appeals Board (EAB). On April 19, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 21-UI-162134 remained in effect. This matter is before EAB based upon claimant's late application for review of Order No. 21-UI-162134.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On March 31, 2021, the appellant filed an application for review of Order No. 21-UI-162134 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than March 24, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is April 29, 2021, making the deadline May 19, 2021 to file the request for reconsideration, *and*
2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

DECISION: The application for review filed March 31, 2021 is dismissed. Order No. 21-UI-162134 remains undisturbed.
