EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0330-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective December 13, 2020 (decision # 120302). Claimant filed a timely request for hearing. On April 5, 2021, ALJ Amesbury conducted a hearing, and on April 7, 2021 issued Order No. 21-UI-164341, affirming decision # 120302. On April 27, 2021, claimant filed an application for review with the Employment Appeals Board (EAB). On June 3, 2021, EAB issued EAB Decision 2021-EAB-0330, reversing Order No. 21-UI-164341 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On July 1, 2021, the employer filed a late request for reconsideration of EAB Decision 2021-EAB-0330 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The employer's late request for reconsideration is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB mailed Appeals Board Decision 2021-EAB-0330 on June 3, 2021. Under OAR 471-041-0145(2), the request for reconsideration was due by June 23, 2021. The employer's request for reconsideration was filed on July 1, 2021, more than a week after the timely filing deadline. OAR 471-041-0145(2) contains no exception to the requirement that a request for reconsideration must be filed on or before the 20th day after the decision sought to be reconsidered was mailed. The employer's request for

reconsideration therefore is dismissed as untimely.

DECISION: The request for reconsideration filed July 1, 2021 is dismissed. EAB Decision 2021-EAB-0330 remains undisturbed.
