# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0340

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective October 11, 2020 (decision #110545). On January 26, 2021, decision #110545 became final without claimant having filed a request for hearing. On February 25, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 23, 2021 issued Order No. 21-UI-163200, dismissing the request as untimely without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 6, 2021. On April 12, 2021, Order No. 21-UI-163200 became final without claimant having responded to the appellant questionnaire or having filed an application for review of Order No. 21-UI-163200 with the Employment Appeals Board (EAB). On April 13, 2021, claimant filed a late application for review of Order No. 21-UI-163200 with EAB and a late response to the appellant questionnaire. On April 28, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's April 13, 2021 application for review.

**FINDING OF FACT:** (1) Order No. 21-UI-163200, mailed to claimant on March 23, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-163200 at 2. Order No. 21-UI-163200 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 12, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-163200 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-163200 was due on April 12, 2021. Because claimant did not file their application for review until April 13, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed April 13, 2021 is dismissed. Order No. 21-UI-163200 remains undisturbed.
