EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0341

Late Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On January 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$1,296 in regular unemployment insurance benefits and \$1,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 142433). On February 1, 2021, decision # 142433 became final without claimant having filed a request for hearing. On February 9, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's late request for hearing, and on March 3, 2021 issued Order No. 21-UI-162018, dismissing claimant's hearing request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 17, 2021. On March 23, 2021, Order No. 21-UI-162018 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 17, 2021, claimant filed a late application for review with EAB and a late response to the appellant questionnaire. On April 27, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's April 17, 2021 application for review of Order No. 21-UI-162018.

CONCLUSIONS AND REASONS: The application for review should be dismissed without prejudice.

On April 17, 2021, the appellant filed an application for review of Order No. 21-UI-162018 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than March 23, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is May 7, 2021, making the deadline May 27, 2021 to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, when claimant changed their address, when or if claimant notified the Department or the Office of Administrative Hearings of the address change, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed April 17, 2021 is dismissed without prejudice. Order No. 21-UI-162018 remains undisturbed.
