EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0352

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective April 1, 2020 (decision #82102). Claimant filed a request for hearing. ALJ Kangas considered claimant's request, and on March 10, 2021 issued Order No. 21-UI-162446, dismissing the request as untimely without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 24, 2021. On March 15, 2021, the Office of Administrative Hearings (OAH) mailed the parties a letter stating that Order No. 21-UI-162446 was vacated and a hearing was to be scheduled regarding the timeliness of appellant's hearing request on decision #82102 and, if appropriate, the merits of that decision.

On February 18, 2021, the Department served notice of an administrative decision replacing decision #82102, concluding that claimant quit work without good cause and was disqualified from receiving benefits effective September 1, 2019 (decision #133305). Claimant filed a timely request for hearing. On April 8, 2021, ALJ Janzen conducted a hearing, and on April 9, 2021 issued Order No. 21-UI-164474, modifying decision #133305 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective February 2, 2020. On April 29, 2021, Order No. 21-UI-164474 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 30, 2021, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 21-UI-164474, mailed to claimant on April 9, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-164474 at 3. Order No. 21-UI-164474 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 29, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-164474 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-164474 was due on April 29, 2021. Because claimant did not file their application for review until April 30, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 30, 2021 is dismissed. Order No. 21-UI-164474 remains undisturbed.
